VENDOR RULES & REGULATIONS

These Rules and Regulations shall be enforced for all vendors commercial, community service clubs, agricultural awareness, and farmers market. Failure to comply with these rules could lead to expulsion from the grounds. This document is part of the contract between vendor and Beaverton Agricultural Society.

INDOOR SPACE	<ul style="list-style-type: none"> • 10 ft. X 10 ft. floor space • one table (8' X 2') and two chairs are provided • hydro is included • vendor must provide their own heavy- duty extension cord
OUTDOOR SPACE	<p>10 ft. x 20 ft. ground space</p> <p>trailers and vehicles may be parked behind display at the Society's discretion</p> <p>hydro is included, vendor must provide their own heavy- duty outdoor extension cord</p> <p>water hookup will be supplied as needed but must be indicated on your application</p> <p>chairs and tables will be provided upon request</p>
INSURANCE	<p>Vendor MUST insure their own goods and/ or equipment against loss • vendor MUST provide a certificate of insurance confirming Commercial General Liability Insurance for a limit of at least \$2 million per occurrence.</p> <ul style="list-style-type: none"> • Certificate of Insurance must include Beaverton Agricultural Society named as "Additional Insured"
TYPE OF OPERATION	<p>PLEASE NOTE: THE SALE OR SUPPLY OF KNIVES, GUNS, LASER POINTERS, PORNOGRAPHIC MATERIAL, ANY DRUGS OR RELATED MATERIALS, OR ITEMS DEEMED INAPPROPRIATE BY THE BEAVERTON AGRICULTURAL SOCIETY WILL NOT ALLOWED, THIS WILL BE ENFORCED WITHOUT EXCEPTION.</p> <p>Products and/or services being displayed must be detailed on the contract</p> <p>food products for sale must pass all Health Code Regulations</p> <p>products and/or services listed on the contract can be displayed</p>
SET-UP And Hours of Operations	<p>You are expected to be onsite Friday from 11 am to 7:00 pm and Saturday from 9 am to 6:30 pm. These are the MANDATORY HOURS that you must be open as our fair visitors pay to come and the see the Fair and this is part of the Fair.</p> <p>A penalty will be incurred if you leave earlier then the specified hours.</p> <p>We are offering a SET UP TIME on the Thursday from 6:00 pm to 8:00 pm and Friday from 9:00 am to 10:30 am.</p>
PASSES	<ul style="list-style-type: none"> • VENDORS receive 2 weekend passes which includes one parking space for the weekend * VENDORS can purchase 10 additional day passes at reduced rate prior Aug 31st * COMMUNITY GROUPS & FREE SPACE must pay for all passes (a 10% fee is applicable sales made when free space given) • VENDORS can purchase 10 additional day passes at a reduced rate per space prior to Friday opening of the fair. (Farmers market does not apply) <p>Passes will be left on your table. You may pick them up during set up times as indicated above</p>

INSURANCE	<p>-Vendor MUST insure their own goods / or equipment against any loss</p> <p>-Vendor must carry enough public liability of 2 million dollars</p> <p>-Proof of insurance must be provided</p>
LIABILITY	<p>The Beaverton Agriculture Society takes precautions to guard against the loss of equipment or display material by providing security Friday till Saturday Night. The society will not assume any responsibility for the loss which might be incurred from pilfering, water damage, fire, or accident or other causes.</p>
BOOTH PREFERENCES	<ul style="list-style-type: none">• the “Society” reserves the right to locate, re-locate or alter the space assigned• vendor does not have the automatic right to occupy the same space as in previous years• space is assigned on a first come first served basis, once contracts are returned with full payment• you must remain within the space assigned <p>NO EXCEPTION unless discussed with Fair Assistant ahead of time</p>
