**RULES AND REGULATIONS**

\*These Rules and Regulations shall be enforced for all vendors commercial, community service clubs, agricultural awareness and farmers market

\*Failure to comply with these rules could lead to expulsion from the grounds

\*This document is part of the contract between each vendor and the Beaverton Agricultural Society

**INDOOR SPACE**

\*10 ft x 10ft floor space

\*One table (8'x2') and two chairs are provided

\*Hydro is included

\*Vendor must provide their own heavy duty extension cord

**OUTDOOR  
SPACE**

\*10 ft x 20 ft ground space

\*Trailers and vehicles may be parked behind display at the Society's discretion

\*Hydro is included, vendor must provide their own outdoor extension cord

\*Chairs and tables will only be provided upon request

**BOOTH  
PREFERENCE**

\*The Society reserves the right to locate, re-locate or alter the space assigned

\*Vendor does not have the automatic right to occupy the same space as in Subsequent years.

\*Space is assigned on a first come first served basis, when contracts returned with full payment

\*You must remain within the space assigned

**NO SUBLETS**

\*Vendors may not under any circumstances sublet any or all of their space Under terms of contract without permission from the Society

**TYPE OF  
OPERATION**

\*All product and/or services being displayed must be detailed on the contract

\*Any food products for sale must pass all Health Code Regulations

\*Only product and/or services listed on the contract can be displayed

\*No Weapons or drug paraphernalia are permitted on the grounds

\*Only authorized draws and lotteries will be allowed

\*The Society reserves the right to demand the removal of any item(s) offered for sale or any operation that was not clearly approved or understood under "Specific Product or Service Being Displayed" on the Contract.

**SET-UP**

\* Thursday 1:00 p.m. to 8:00 p.m.

\* Friday 8:00 a.m. to 11:00 a.m.

• Farmers Market Sunday 8:00 a.m. to 10:00 a.m.

**HOURS OF  
OPERATION**

\*Displays must be open and ready for the public each day when the fair opens.

\*Displays must not be dismantled in any way until after 4:00 pm on Sunday

Any Items left behind will become the property of the Society

\*Displays must be staffed during all hours of fair operation (subject to change)

Friday 12:00 p.m to 10:00 p.m.

Saturday 9:00 a.m. to 9:00 p.m.

Sunday 8:00 a.m. to 4:00 p.m.

Farmers Market Sunday 10:00 a.m to 4:00p.m.

- DISPLAY**
- \*Vendors must have a clean, respectable booth or display suitable for family Viewing
  - \*Displays, advertising material, demonstrations and/or product sold must be kept within the confines of your space
  - \*When using sound and/or video ensure that disturbance to the neighbouring vendor is minimal
- LIABILITY**
- \*The Society takes precautions to guard against the loss of equipment or display Material by providing security Thursday until Sunday
  - \*The Society will not assume responsibility for the losses which might be incurred from pilfering, water damage, fire, accident or other cause.
- INSURANCE**
- \*Vendors MUST insure their own goods and/or equipment against any loss
  - \*Vendors MUST carry sufficient public liability insurance
  - \*Proof of insurance must be provided.
- FIRE REGULATIONS**
- \*The Vendor agrees to observe all Fire Regulations and maintain acceptable Fire prevention practices as required by the Township of Brock
- GARBAGE**
- \*All garbage must be placed as directed
- PASSES**
- \*COMMERCIAL VENDORS receive 2 Weekend Passes and 1 Parking Pass for Each 10 ft x 10 ft space
  - \*Farmers Market receive 1 Day Pass and 1 Parking Pass for each space
  - \*COMMUNITY GROUPS & FREE SPACE – Must Pay for All Passes at the reduced rate on contract (a 10% fee is applicable to sales made when free space given)
  - \*An additional 6 weekend passes or 18 day passes or a combination thereof can be purchased at a reduced rate per space prior to Friday opening of fair (Farmers Market Do No Qualify)
- PARKING**
- \*COMMERCIAL VENDORS – One Free Weekend Parking Pass will be provided To park in the lot across the road from the main gates
  - \*Farmers Market – One Free Parking Pass for inside the Gates on Sunday only
  - \*Additional Parking Passes may be purchased prior to Friday opening of fair
  - \*Parking on the fair grounds will be allowed ONLY while moving in, making deliveries or moving out (Farmers market Excepted)
  - \*Deliveries MSUT be made before the fair opens daily
- CANCELLATION**
- \*Cancellations before August 31 will receive a full refund
  - \*The Society reserves the right to cancel this agreement at any time if in it's the opinion the terms and conditions of this contract are not being observed.
